

1. OBJECT

1.1. The present Terms&Conditions define general conditions of all sales at <http://prereg.eja.net>, property of European Juggling Association - registered in Amsterdam, the Netherlands and named from now on EJA - and established between it and the user, regulating the online purchase of tickets and/or merchandising for the 41st European Juggling Convention - EJC 2018.

2. DEFINITIONS & INTERPRETATION

2.1. "We", "Us" "Our" and/or "Our" refers to European Juggling Association.

2.2. "You" means you or anybody else who, in Our reasonable opinion, is acting with your authority or permission. "Your" and/or "Yours" shall be read with the same interpretations

2.3. "Promoter" refers to Associação de Artes Circenses dos Açores 9'Circos, with office in Ponta Delgada, who is responsible for staging and managing the 41st European Juggling Convention.

2.4. "Event" refers to the 41st European Juggling Convention - or EJC 2018 - occurring on a single period from 28th of July to 5th of August 2018, in Ribeira Grande city, São Miguel Island, Azores Archipelago, Portugal and for which We have the right to sell tickets for

2.5. "Ticket" or "Tickets" defines one and/or more tickets or any other types of evidence (including electronic tickets) that provides admission for the Event, sold to You by the Promoter through Us.

2.6. "Venue" means any facilities and/or locations of any nature where the Event is being held.

3. CONTRACT & AGREEMENT

3.1. The present Terms&Conditions regulate the purchase and selling of Tickets for the Event through <https://prereg.eja.net>.

3.2. They are public and made available to You and any other user through XXXXXXx and should be read before any transaction.

3.3. Upon the purchase of a Ticket or Tickets We assume that You read and accept the present Terms and Conditions as well as any others that may apply.

4. TICKETS

4.1. The Tickets for EJC 2018 are sold only through Our Web Platform <https://prereg.eja.net>.

4.2. In case You find Tickets available in any other location, physical and/or online, You should not buy them and report the situation to Us and to the Promoter.

- 4.3. Tickets' availability is subject to the Venue capacity and these Terms and Conditions.
- 4.4. Removing, altering and/or defecting the Ticket may invalidate it with no entitlement to refund.
- 4.5. It is Your responsibility to check Your information and Tickets as after purchase, changes are not possible.
- 4.6. We and the Promoter are not liable for any Ticket that is lost, stolen or destroyed
- 4.7. Ownership or possession of a Ticket does not confer any rights (by implication or otherwise) on You to use, alter, copy or otherwise deal with any of the symbols, trade marks, logos and/or intellectual property appearing on the Ticket.

5. ACCESS TO THE VENUE

- 5.1. Access to the Venue is limited to Bracelet owners.
- 5.2. To access the Venue You should present Your Ticket and exchange it for a bracelet at Registration Desk.
- 5.3. The Registration process is only possible in person provided a valid Government-issued ID.
- 5.4. Upon Ticket exchange the bracelet is immediately placed on Your wrist or ankle and considered void if damaged or lost with no entitlement to refund and Venue access will be denied.
- 5.5. The bracelet allows You to freely move within the entire Venue without the need to constantly present Your ticket.
- 5.6. You should preserve the Ticket until the end of the Event as for security reasons it might be needed.
- 5.7. For children under 16 (sixteen) years old, the bracelet will only be provided upon presential Parents or Legal Guardian authorization proven by appropriate ID's and/or certified documents.
- 5.8. For Juveniles with 16 (sixteen) and 17 (seventeen) years old, the bracelet will be provided upon presential or written Parents or Legal Guardian authorization proven by copies of ID's and/or certified documents.
- 5.9. Children under 16 (sixteen) years old are not allowed on the Venue unless accompanied by their parents or certified Legal guardians.
- 5.10. To any children or juvenile that does not comply with following 2 points, access to the Venue will be denied with no entitlement to refund.
- 5.11. The access to the Venue is subject to individual search by Police Officers and/or Security Team members, with legal authorization for such and always properly identified.
- 5.12. The Promoter reserves its right to admission and access to the Venue will be denied to visibly disturbed and/or intoxicated individuals that might disturb the normal course of the Event.
- 5.13. Bracelets misuse may lead to confiscation and expulsion of the participant from the Event.
- 5.14. Damaged or lost bracelets will not be replaced.

6. PRICE & PAYMENT

- 6.1. The price of the Ticket varies according to the date of purchase and are stated at ejc2018.org
- 6.2. Some prices are limited by dates and/or number of purchases.

- 6.3. Simultaneous purchases in different accounts/devices are not possible and sales will always take place by order and according to previous point.
- 6.4. All prices set are inclusive of any applicable taxes.
- 6.5. Prices are available in Euros (EUR) and British Pound Sterling (GBP).
- 6.6. Currency fees may apply.
- 6.7. Payment methods available are bank transfer and credit/debit card.
- 6.8. Transaction fees may apply.
- 6.9. No purchase is considered final until payment of respective full amount.
- 6.10. Tickets that are purchased and not paid within set time limit will be considered unsold and will be made available for public.

7. GENERAL RULES

- 7.1. The Promoter holds domiciliary rights within the Venue.
- 7.2. The Venue is not owned or managed by The Promoter but by a third party site owner.
- 7.3. The Promoter's instructions, as well as any from its Security personnel such as stewards and/or Police are to be followed.
- 7.4. Any type of animal, domestic or not, are not allowed anywhere within the Venue.
- 7.5. Wild fires are prohibited, except in areas that are explicitly marked for this purpose. All participants are requested to ensure fire safety on the Venue.
- 7.6. Drug consumption is prohibited.
- 7.7. Consumption of alcohol is prohibited for everyone under 18 (eighteen) years old. Applicable laws will be enforced.
- 7.8. Alcohol consumption is also entirely prohibited within the camping area reserved for families.
- 7.9. The Promoter reserves the right to deny the access to the Venue of persons who violate these conditions with no entitlement to refund or any type of compensation.

8. RECORDINGS

- 8.1. During the event, recordings on the format of photography, video, audio and/or similar will take place by authorized Promoter's personnel.
- 8.2. The persons captured within the previously specified recordings are giving their consent upon the purchase of the Ticket if not otherwise stated.
- 8.3. The captured recordings will be used for promotion, advertising and other purposes that may suit Us or the Promoter with no entitlement to any type of compensation.

9. LIABILITY

- 9.1. Participation in the event is entirely at the participant's own risk.

- 9.2. Participants are responsible for monitoring their safety as well as third-parties
- 9.3. The Promoter will only be liable in the event of willful conduct or gross negligence.
- 9.4. The Promoter is not responsible for lost or stolen property.
- 9.5. Participants are liable for any damages caused by them to themselves, third-parties or material goods, as specified by law.

10. FINAL CLAUSES

- 10.1. The Event and these Terms&Conditions are subject to Portuguese Law and European Union Directives.
- 10.2. In case of doubt, the English version of the Terms and Conditions is binding.
- 10.3. Place of jurisdiction is Ponta Delgada, São Miguel, Açores.
- 10.4. In the event that individual clauses and/or rules on the website and/or the present Terms and Conditions are invalid or become invalid at a later date shall be replaced by the rule that is valid and best fits the invalid rule in terms of objective and economic prudence.
